2. Quality premium: Additional 5 cents per bushel if the following factors are met:
- Test weight above 60.0#
 - Less than 3.0% damage
 - Falling number > 325
 - Zero sprout damage
 - Vomitoxin less than 2.0 ppm (if tested)

Discounts:

Grain delivered which has quality factors below #2 SRW will be subject to normal discounts as stated on the current SMC discount sheet. Discounted loads except dockage and moisture will **not** be eligible for the quality premium or test weight premium.

Pricing:

Deferred Pricing, Forward Price Contracts, Basis Contracts, Option Strategies and Storage will be offered and based on market values at the time of contracting.

Requirements for the program:

1. We require the use of a Professional Wheat Consulting Service. **Midwest Wheat, Agronomy One, Crop Vision Consulting, Advanced Agrilytics, Innovative Input Solutions, Oak Valley Ag and Marco N.P.K. Inc (Rick Dow)** are approved providers of these services. We have worked with these companies and have great confidence in their ability to add value to your wheat production.
2. Wheat will be delivered to SMC at Teutopolis or Montrose, Illinois and must meet milling quality specifications.
3. Producer must use SMC recommended practices for treating and storing grain.
4. In the event of lower quality due to weather conditions, the producer must make a good faith effort to deliver contracted grain to SMC.
5. SMC is contracting for food grade quality wheat. Any deception such as plugged loads, adulteration of grain or delivery of treated grain will result in termination of this contract.
6. **Entry deadline is May 31, 2027. Signed contracts must be returned on or before this date to be eligible.**
